NOTIFICATION

Islamabad, the 14th June, 2018

S.R.O. 1048(I)/2018.—In exercise of the powers conferred by section 4 of the Compulsory Teaching of the Holy Quran Act, 2017 (XXX of 2017), Minister-in-charge for Federal Education and Professional Training is pleased to make the following rules, namely:—

1. **Short title and commencement.**—(1) These rules may be called the Compulsory Teaching of the Holy Quran (Muslim Students) Rules 2018.

(2) They shall come into force at once.

2. **Definitions.**—(1) In these rules, unless there is anything repugnant in the subject or context,—

(a) “Act” means the Compulsory Teaching of the Holy Quran Act, 2017 (XXX of 2017);

- (b) "grades" include, classes, forms, level or whatever term is used for this in educational institutions;
- (c) "Schedule" means schedule to these rules; and
- (d) "translation" means such translation of the Holy Quran which has been developed in consensus with Ittehad Tanzeemat-ul-Madaris Pakistan.

(2) The terms used but not defined herein shall have the same meanings as are assigned to them by the Compulsory Teaching of the Holy Quran Act, 2017 (XXX of 2017).

3. **Scheme of teaching.**—(1) The unit of the Naazrah Quran shall be taught to the students as per Schedule I.

(2) In all educational institutions, translation shall be taught in Grade VI to Grade XII as per Schedule II.

4. **Implementation Framework.**—The implementation of this Act shall be the responsibility of the concerned Divisions in accordance with their responsibilities.

5. **Implementation in the educational institutions.**—The implementation requirements in the educational institutions shall be as follows,—

- (a) budget arrangement related to provision of Qari or Qaria, teacher training, Quran or Paras, books, teacher guides and such other teaching material that is deemed necessary, shall be the responsibility of the concerned Divisions or Departments or embassy etc.;
- (b) a teacher well versed with tajweed rules, shall teach Naazra Quran and translation of Quran in the educational institutions;
- (c) teaching of Naazra and translation shall be ensured during already prescribed Naazra and Islamiyat periods on priority basis. However, more time may be assigned as and where needed. Inclusion of Naazra and translation period in the time table will be the responsibility of the concerned head of the educational institution;
- (d) arrangement of place for Wudu (ablution), properly keeping the Paras or Quran or booklets, congenial environment for teaching of Quran and alternate arrangement for the non-Muslim students and the ones who have already finished Naazra shall be the responsibility of the concerned head of the educational institution;

- (e) capacity building of the teachers, involved with the Naazra and translation of the Holy Quran, shall be ensured with essential skills including (Tajweed, Qirrat etc.) for correct teaching of the Holy Quran. The concerned Division Department or Embassy etc., shall be responsible for such arrangements on regular basis; and
- (f) monitoring officers or area educational officers or any designated person shall be responsible for monitoring and submission of periodical report to the concerned Director Schools, Colleges or Department.
